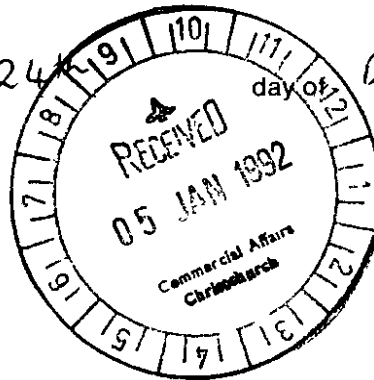

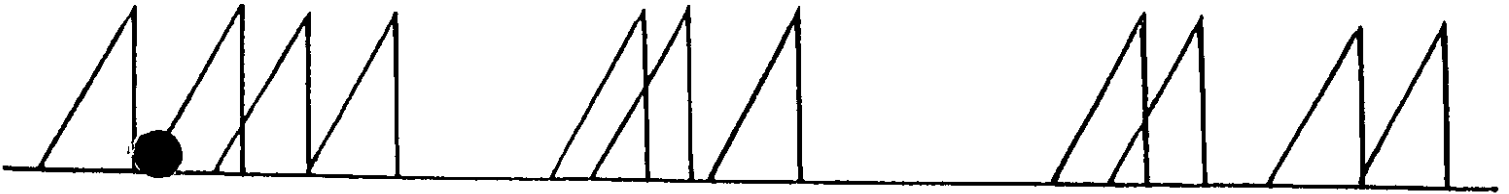

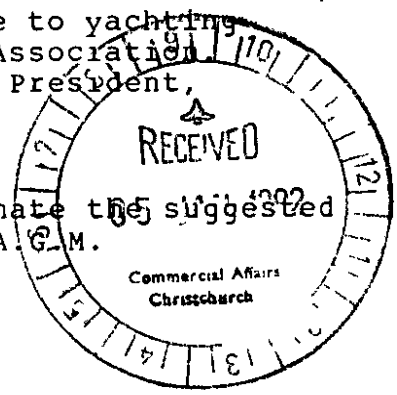
At the Annual Meeting of the Canterbury Yachting Association 16 6 92 an additional clause 5 (d) was added to the Constitution.

Clause 5, (D)

1. HONORARY LIFE MEMBERSHIP

In recognition of outstanding service to yachting as an officer or member delegate of the Canterbury Yachting Association the award of Honorary Life Membership may be awarded. This award to be presented from time to time at the Annual General Meeting. The Honorary Life Member shall have the privilege to attend meetings and to speak but no right to vote unless as a delegate member

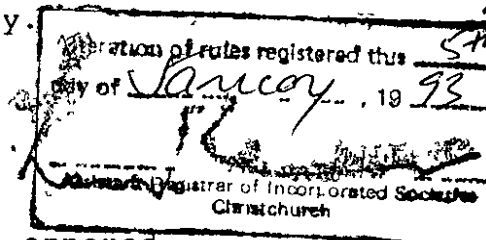

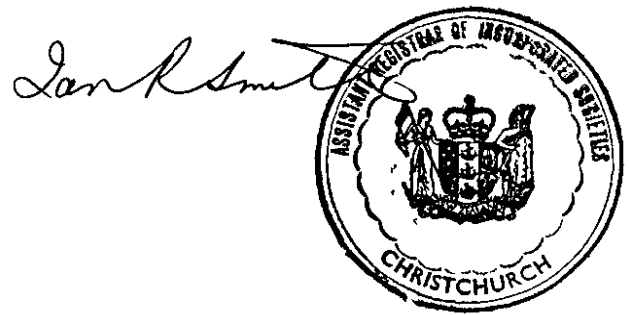
111 After consideration the sub committee may nominate the suggested person as an honorary life member at the next A.G.M.
